Vision

We envision a healthy community in which seeking, receiving, and implementing help for substance use and mental health concerns is as natural as utilizing the services of doctors and hospitals for physical health issues.

Mission

The Open Door is a non-profit behavioral health organization designed to provide treatment and services for substance use and gambling related concerns; impaired driving programs; and crisis intervention services for Armstrong and Indiana County residents with a focus on inspiring steps toward hope, courage, and recovery.

History

The Open Door was founded in 1972 as a United Ministry Volunteer Task Force offering a crisis hotline staffed by volunteers. Since that time, we have grown into a licensed outpatient facility providing a variety of services including Screening, Assessment, Education, Intervention, and Treatment for Substance Use and Gambling Disorders; 24-hour Crisis Intervention Services offered by phone, walk-in, and mobile; and Evaluation and Education for DUI Offenders.



In 1996, an affiliation agreement with Indiana Regional Medical Center (IRMC) was established to increase access for services.



In 2012, TOD partnered with Armstrong-Indiana Behavioral and Developmental Health Programs (AIBDHP) to develop our volunteer hotline into a 24-hour licensed Crisis Intervention Service, adding walk-in crisis services in addition to telephone intervention, then adding mobile crisis services in 2012.

With the funding and support of the Armstrong-Indiana-Clarion Drug and Alcohol Commission (AICDAC) TOD became a licensed Alcohol and Other Drug Outpatient Treatment Center in 1973 offering Outpatient and Intensive Outpatient Programming. The Open Door started offering Medication-Assisted Treatment with Buprenorphine in 2003 through an affiliation with local prescribers. In 2008, with support and funding from the United Way, TOD began providing services in our local schools to youth who struggled to access services in the office due to the rural nature of our community. Indiana County Jail opened its doors to TOD in 2010 so that TOD could provide treatment to inmates. Up to 2011, TOD coordinated medication-assisted treatment with community physicians for persons with Opioid Use Disorder (OUD). In 2012, TOD offered Buprenorphine treatment in-house and began accepting Methadone clients into services. 2012 also saw the development of a routine joint staffing meeting with the Community Guidance Center to further improve coordinate care for persons with co-occurring disorders. In 2013, Partial Hospitalization Programming as well as a Nurse Navigator position to help address and coordinate care for physical and mental health needs were added. In 2015, TOD coordinated with Positive Recovery Solutions to offer Vivitrol for persons with OUD and Alcohol Use Disorder (AUD). TOD began offering Sublocade treatment in-house in 2019.

Our Programming



There are three main departments at The Open Door. The **Clinical Department** is licensed by the Department of Drug and Alcohol Programs as an Alcohol and Other Drug Outpatient Treatment Facility providing services to persons with substance use and problem gambling disorders and their loved ones. The **Crisis Department** is licensed by the Office of Mental Health and Substance Abuse Services as a Crisis Intervention Service that provides services to any individual experiencing a crisis situation. Services are provided to anyone, anywhere, and anytime within our two-county service area. The Open Door has been designated as the DUI Coordinator for Indiana County. **The Impaired Driving Program** provides Court Reporting Network Evaluations and Alcohol Highway Safety School to DUI offenders in Indiana County.

Our Clinical Services

The Open Door provides Pre-Screening, Assessment, Early Intervention, Intervention, Outpatient Counseling, and Medication-Assisted Treatment(MAT) to individuals and family members for substance use and gambling concerns.

Our Clinical Department, licensed under the Department of Drug and Alcohol Programs (DDAP) which provides outpatient treatment services to persons with Substance Use Disorders (SUD), Problem Gambling, and their loved ones, is no slouch either. Our census increased by 30% this year. Additionally, with the support and funding of the Armstrong-Indiana-Clarion Drug and Alcohol Commission (AICDAC), we now have a full year under our belt of being able to offer Early Intervention programming for those at risk of developing SUD and Substance Use Interventions for those with SUD who are struggling with entering treatment at no cost to Indiana County residents. AICDAC also provided additional funding to purchase new technology equipment so that group services can be provided via telehealth. Additionally, the clinical team has been trained and is able to offer two new evidence-supported treatments: Pain Reprocessing Therapy and Emotional Freedom Technique (Thank you AICDAC and United Way!).

Our Crisis Intervention Services

The Open Door provides telephone, mobile and walk-in crisis services. Crisis services operate 24/7 & include de-escalation, emotional support, problem-solving / exploring options, referrals, facilitating access to mental health care, and warm hand-offs.

Our licensed Crisis Intervention Service (CIS) that started out as a small volunteer crisis hotline founded in 1972 by the United Ministry Task Force is growing again! We provide crisis intervention 24/7 via phone and mobile in Indiana and Armstrong Counties and walk-in services 8 hours daily in Indiana County. We obtained state and federal funding with the help and support of Armstrong-Indiana Behavioral Health and Development Program (AIBDHP) this fiscal year to expand these services to start a text line, provide daily walk-in services in Armstrong County and 24-hour walk-in services in Indiana County. We are happy to tell you that the text line was up and running January 1st, 2023, and Walk-in services started in Armstrong County on August 7th of 2023! 24-hour Walk-in Services to be provided on our partner's, Indiana Regional Medical Center (IRMC), campus in Indiana County are in the works!

Our Impaired Driving Services

The Open Door is the DUI Coordinator for Indiana County. Evaluators and instructors provide Court Reporting Network (CRN) Evaluations and facilitates Alcohol Highway Safety School (AHSS) programming for DUI offenders in Indiana County.

The Impaired Driving Department, which provides Court Reporting Network (CRN) Evaluations and Highway Safety School (HWSS) for persons convicted of DUI's in Indiana County began offering services via telehealth this year as well, increasing access and improving attendance of these court-mandated services. Our DUI Coordinator and Clinical Treatment Team have also collaborated with Indiana County Courts and Indiana County Probation to provide pre-screening and scheduling services during DUI Criminal Call Hearings to streamline the process of completing court requirements for defendants. Due to close coordination with our partners in law enforcement and increasing access to our services through the use of telehealth, we've been able to provide more services. CRN completions rose 12% and HWSS completions rose by 49% this year.

Our Crisis Intervention Outcomes

73% of respondents to follow-up calls were engaged I some form of follow-up care or structured setting following crisis intervention.

Consumer-Family Satisfaction Team Results

The crisis worker was able to get my child to talk about the problem, which is highly unusual. My child has never shared what was wrong but in 45 minutes the crisis worker was able to find out from my child. Also due to the crisis worker's referral, my child was able to get an appointment with a psychiatrist within 6 days.

I lived.

I was able to talk through my situation and get my head on straight.

The crisis worker calmed me down. Before I called the crisis line I was thinking about killing myself. It was a scary situation. The crisis worker did a fantastic job with our child. They were focused on resolving the situation, very responsive, and very timely.
